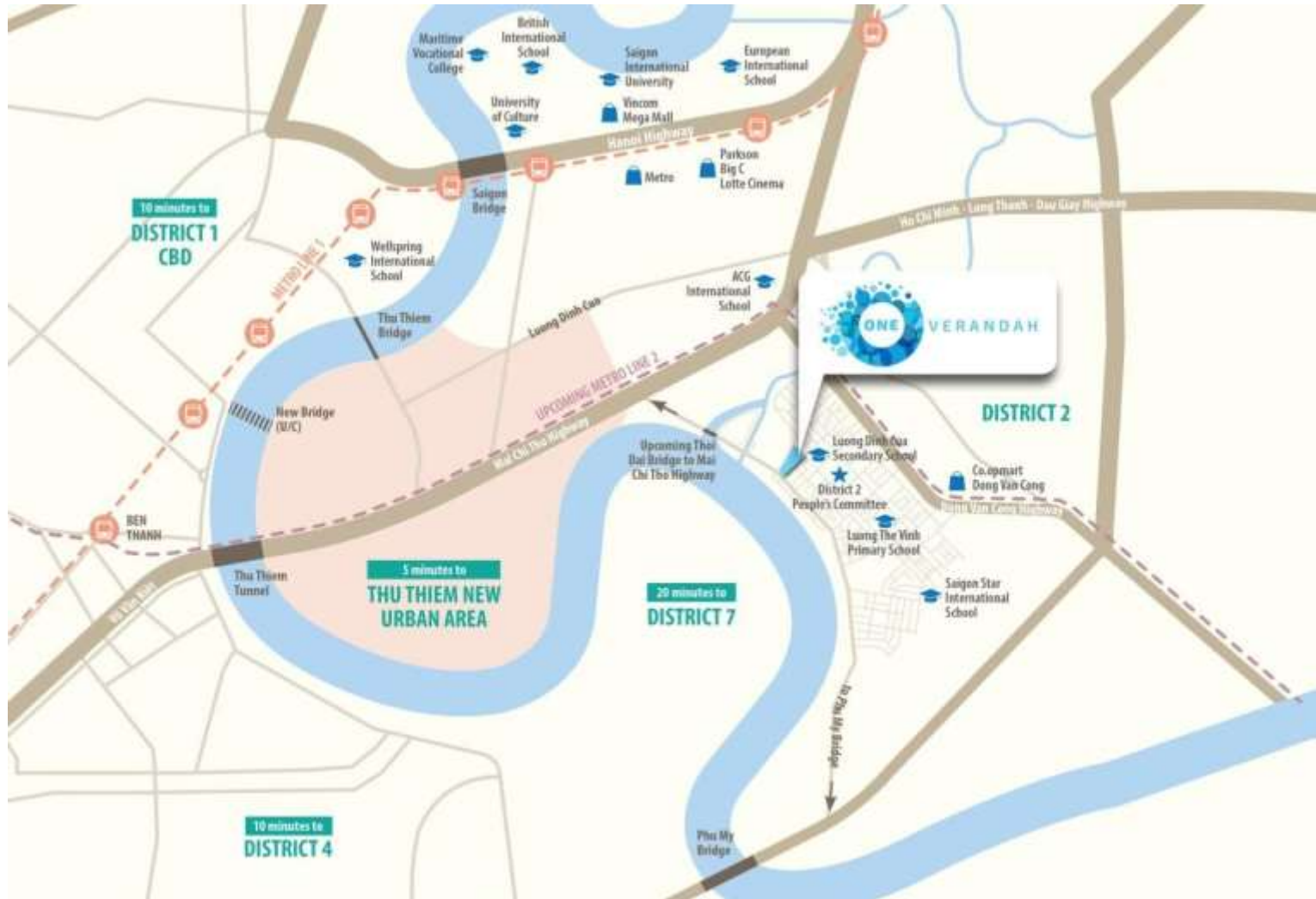


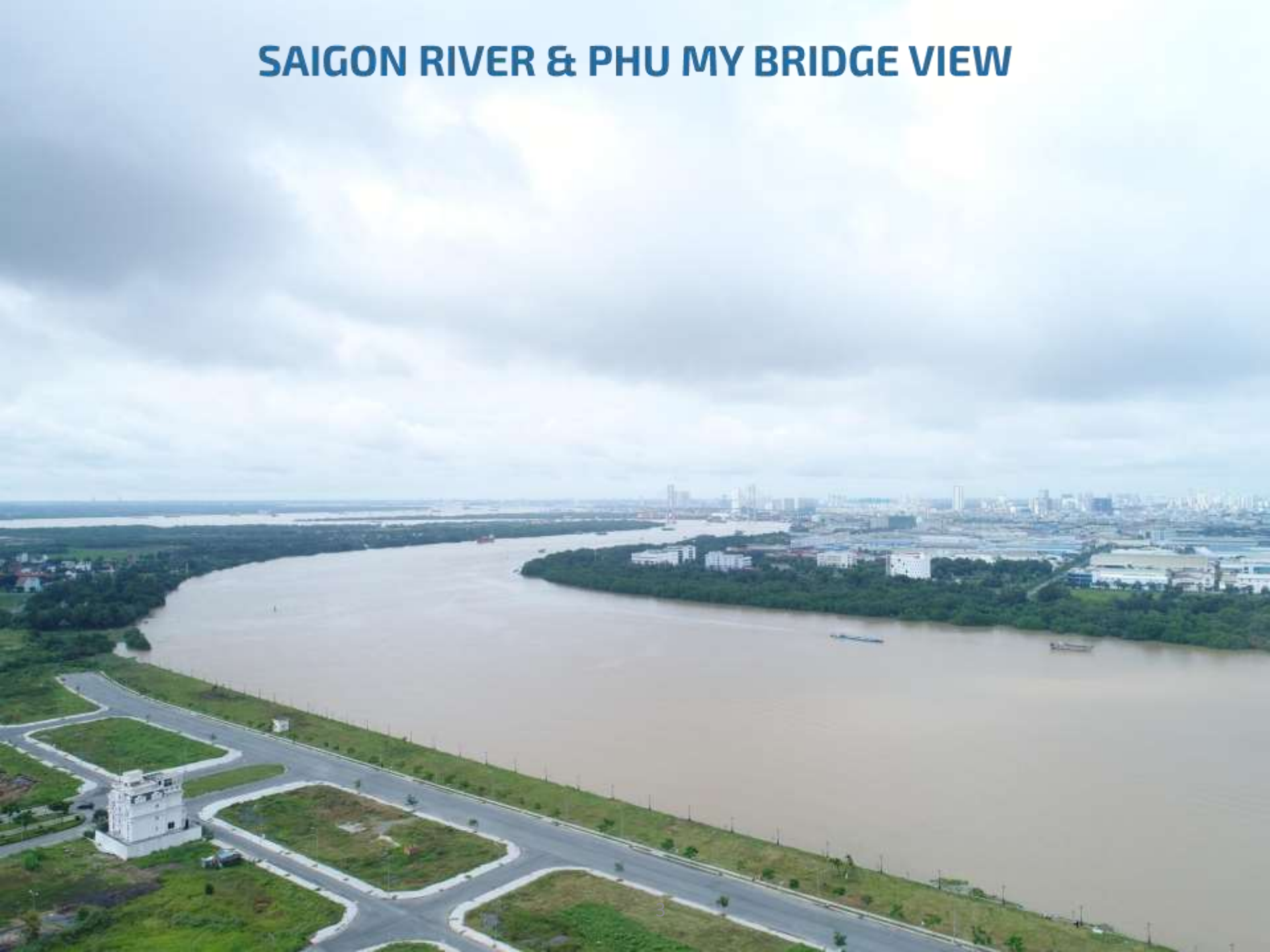


# LOCATION MAP

# SAIGON RIVER & PHU MY BRIDGE VIEW

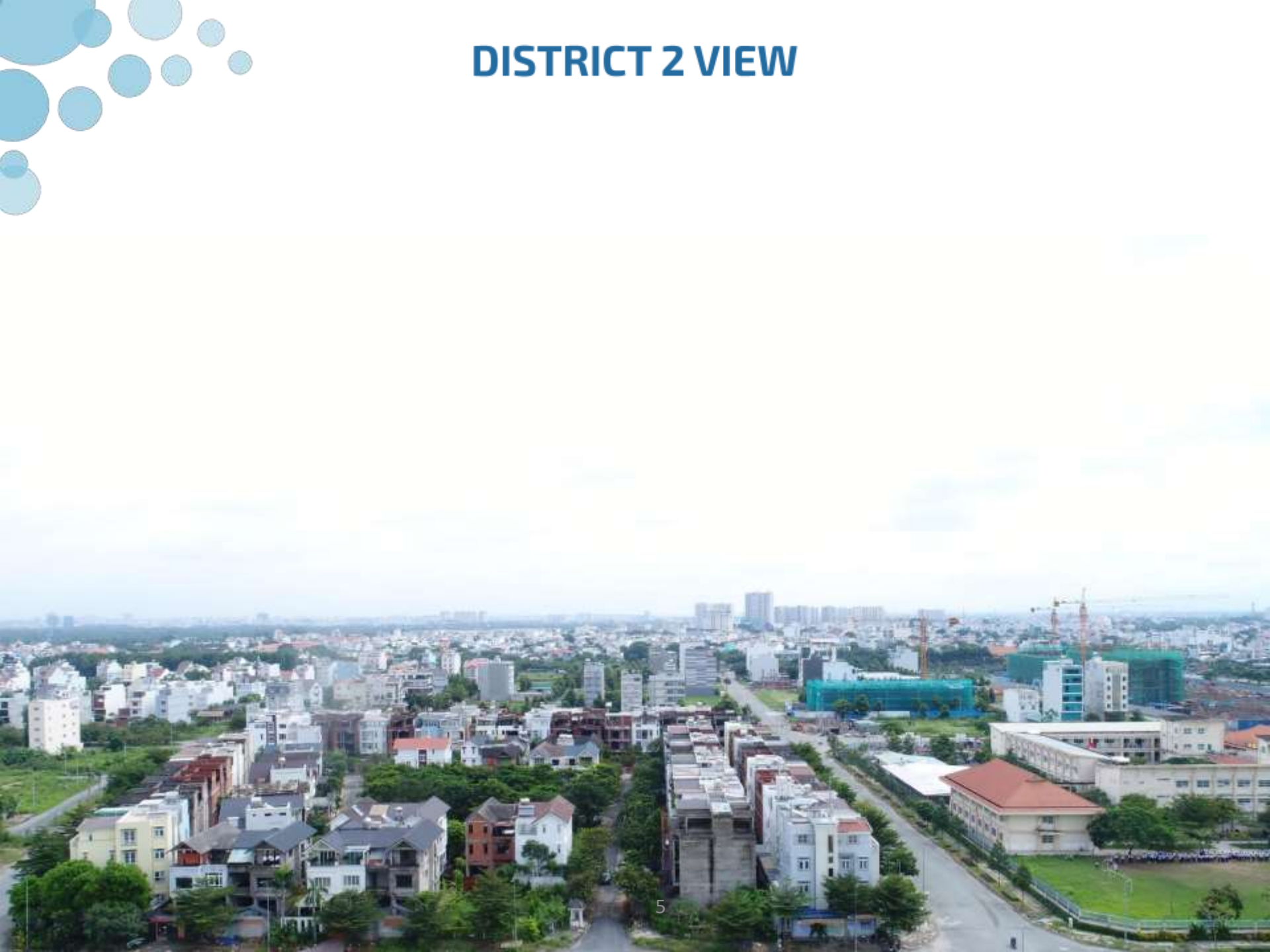
